The Affordable Care Act (healthcare reform law) requires that employers provide employees with SBC(s) in order to compare health plans when making decisions and enrolling in coverage. # LONG-TERM CARE INSURANCE (LTCI): ENROLLMENT DEADLINE EXTENDED TO DECEMBER 31, 2012

Eligible employees and family members can enroll in the MetLife LTCI program until December 31, 2012. If interested, you must request an enrollment kit from MetLife by calling 1-800-984-8651 before November 30, 2012. Completed applications must be received by MetLife no later than December 31, 2012. ### NEW ONLINE-ONLY ENROLLMENT PERIOD: October 8, 2012 – November 4, 2012

This year, you will have an opportunity to make your elections on the Your Benefits Resources™ (YBR) website beginning Monday, October 8, 2012 at 9:00 a.m., Eastern Time (ET), through Sunday, November 4, 2012.

During this time, you may view your 2013 coverage and costs, and enroll or make changes to your 2013 coverage — online only — at <a href="http://resources">http://resources</a>.hewitt.com/alcatel-lucent.

You will not be able to call the Alcatel-Lucent Benefits Center to enroll in or make changes to your 2013 coverage, or to ask questions about your 2013 plan options and pricing, until the annual open enrollment period begins on Monday, November 5, 2012 at 9:00 a.m., ET.

### YOU WILL NEED YOUR YBR PASSWORD

You will need your YBR password to access your personalized benefits information and enroll. If you do not remember your YBR password, you can request a new one through the YBR website. It can be sent to you by email, if you previously added your email address to the YBR website, or by U.S. mail. Through the mail, it may take up to 10 days to receive your password.
